

# Competitive Program Financial Commitment

## WG COMPETITIVE PROGRAM Financial COMMITMENT

### 1. 10 month Commitment

Competitive programs require a 10 month commitment and committed payment for the 10 months of training from Sept to June. Coaches are hired from September to June, so withdrawing early from a competitive program (other than a medical reason) would negatively impact the club. Any special circumstance refund request for withdrawal must go to the Executive Director and form to be filled out.

### 2. Payment Schedule

- **June 1st-July 15th:** Returning athletes must secure their spot for the following year, with the GBC Insurance fee and admin fee.
- **July 16th-** Late penalty of \$100 for Returning athletes and spots will be offered to new athletes.
- **Sept 1st:** First program payments will be September 1st. If a 10 month payment plan is selected, Uplifter will charge credit on file on the first of every month Sep-June 1st. Participants can't start until program registration including fee arrangements are complete. Late fees will be charged after that time.

**3. Program fees and extra costs.** Competitive programs are more expensive because they include more training time, added costs for team uniforms and to meets/events and for travel transportation/accommodation.

#### Included in Program Fees

- Training hours
- Events days, Mock meets and rewards, prizes, certificates
- Choreography of floor and beam routines, optional trampoline routines provided for tramp athletes.
- Meet expenses for your designated included meets (athlete entry fee, a share of your coach's registration, wages, travel and accommodation)
- Some Programs include training suit, hoodie, and/or workshops. Check the competitive program information sheet for your program.

#### Extra Costs

- **Travel and accommodations for your athlete and any family for ALL meets.** Parents are responsible for taking your child to meets, so you or your designate will be going and staying with your athlete.
- Expense for athletes who attend additional competitions (i.e. Provincial Championships, non-included invitationals) and training camps (WAG or TG) or qualify for a GymBC or GymCAN team. Families will be required to cover all \*meet expenses, (athlete entry fee, your coach's registration, coaching wages, travel and accommodation) as well as your athlete travel and accommodation.
- [Team Uniforms](#) are changed every 4 years (only WAG 8-12 and TG Level 1+)
- Extra costs are billed to your account for payment and should be paid with-in 2 weeks of the billing.

## Program Transfers, Withdrawal or Suspension

The athletes, staff/coaches, volunteers, families, and guests are expected to respect the codes of fair play and ethical behavior, harassment and inclusion policies, and safety-first practices established by the club, Gymnastics BC, Gymnastics Canada, Coaching Association of Canada and the Whistler Sport Legacy Society and Pemberton facility agreements.

Membership can be suspended or withdrawn for non-compliance based on BOD approval.

6.1 Whistler Gymnastics reserves the right to remove athletes from program participation or suspend participation for a period, for training issues, behavioral or safety issues, bullying or violence.

6.2 Refunds may not be requested for short term suspensions (under 3 weeks).

6.3 Refunds may be considered for longer suspensions or removals. WG is not required to refund for suspension or removal, however consideration can be given.

6.4 Program suspension/removal and consequential refunding is at the discretion of WG Executive Director.

6.5 A 10% administrative fee for class transfers, withdrawals or refunding (within the policy limits) will be charged to cover the added administrative time for these tasks and to discourage holding spots in several classes.
